2	Draft Minutes of previous meetings	
	It was decided that the many points that should be raised about the Minutes of the 12 th August and 16 th September meetings should be considered at a later meeting as those responsible for them were absent.	
	Matters arising	
	RB noted that the current meeting was proposed, discussed and agreed at the Committee meeting on 8 th July, replacing one that was scheduled for the 7 th October as part of the original block of six meetings, booked in January 2025. The current meeting was booked by the Secretary and paid for by the previous Treasurer, David Aspinall.

3	Two Motions of No Confidence

	MW introduced the two Motions as being necessary to restore order and democracy in the Committee but also as a response to the many complaints received in recent times from plot holders.
